“The terrorist trap” A response to terrorism that:

1. Polarizes society
2. Alienates potential allies
3. Requires an unsustainable commitment
4. Undermines your own legitimacy
5. Strengthens opponents

Action-repression-action



From the “terrorist trap” to the “extremist trap”



Ben Jones

“The extremist trap” A response to extremism that:

1. **Mainstreams the extremist agenda**
2. **Focus on narratives and not in psychosocial needs and networks**
3. Polarizes society
4. **Cut social cohesion "not to lose elections"**
5. **Unprotects minorities in favour of the hegemon**
6. Alienates potential allies
7. Requires an unsustainable commitment
8. Undermines your own legitimacy
9. Strengthens opponents
10. **Erodes liberal democracy, the rule of law and the welfare state.**

Avoid transfer between prevention pyramid levels




Figure 7. Levels of prevention of radicalization according to the different levels of radicalization of narrative and action. Own elaboration.

New societal approaches into P/CVE

- Prioritising **social cohesion initiatives** to address underlying social grievances and strengthen community resilience against extremist narratives and inspired activities.
- The mainstreaming of P/CVE policies, integrating them into **broader security and governance frameworks**.
- Incorporating **emotional governance** strategies to navigate uncertainty and promote mental health well-being within communities.
- Implementing **strategic communications** (stratcomms) campaigns featuring new, credible voices to counter misinformation and extremist propaganda effectively.
- Transitioning from youth-informed to **youth-led policy-making**, empowering young people as agents of change in shaping responses to societal challenges.
- Emphasising **gender mainstreaming as a cross-cutting element in P/CVE policies** to ensure that gender perspectives are integrated into all aspects of programme design, implementation, and evaluation.

WHAT WE KNOW...

.....

Youth workers support:

- Young people **aged 13-18**
- They are most concerned about their **young men**
- Many of their young people have additional, complex needs – **intellectual disabilities or social, emotional mental health needs (SEMH)**
- Youth workers are already experts in mentoring and youth work



WHAT WE ALSO KNOW...

.....

1. Training does not equal learning
2. Learning does not equal behaviour change
3. Individual behaviour change does not equal organisational change
4. Returning a changed person to an unchanged organisation is
hopeless; more than one person is needed to create a critical mass
5. Measuring change needs **differentiating** for the adults, the young
people, the learning requirements, the genders, the geographies,
the way each YP was involved...



THE WHOLE TRUTH?

.....

What might traditional programme evaluation data NOT tell us?

e.g. '80% of participants have a better understanding of consequences of rioting'

BUT:

what does understanding look like? What does it lead to? In what ways is this indicator understood differently by different participants? What specific element of the intervention can we credit this 'success' to?

HOW DO WE LEARN FROM THIS?



BUILDING OUR EVALUATION RESPONSE

Peer to peer evaluation and training activities

Activities for young people to develop their own indicators

Reflective activities throughout the programme

Visual aids – thermometers and mountains

Production of content – YPs explain what they have made and how it is relevant to the desired outcomes of the programme






Mrs Bee as a practitioner

- Professional development
 - Optional, based on personal interest
 - Mandatory courses chosen by the school direction
- No interaction with policymakers



Mrs Bee as a researcher


- Participating in academic discussions in national and international contexts
- Research findings turned into courses (!):
 - Courses of professional development for in-service teachers, youth workers and the police
 - Playbook for situations of concern
- Collaboration with policy-makers (!)
 - Drafting of guidelines for PVE-E



Mrs Bee as a policymaker

- Inviting researchers in round-table discussions (!)
- Inviting practitioners in round-table discussions (!)
- Analysis and understanding of the situation
- Presentation of the situation report to the city board and ideas for the next steps (needed interventions, resources & budget)





- Researchers to policymakers (policy briefs)
- Policymakers to researchers (tailored reports)
- Researchers to practitioners (trainings, courses)
- Practitioners to researchers (in studies)
- Practitioners to policymakers (through surveys)
- Policymakers to practitioners (information)

- Communication from policymakers to practitioners remains weak and challenging
- However, it would be central for successful implementation of new laws, regulations, and conditions

Public sector: evaluation and money

- Evaluation of funded projects linked to **saving of public money**
 - How to measure something that didn't happen?
- Challenge: **to fund innovations**
- Question of **values**



Public sector: learning from mistakes

- **Evaluation criteria not expressed** clearly enough
 - Lack of clarity damages trust
- **Power disparity** not taken into account (e.g. resources available)
- **Lack of understanding** of (sub)culture
 - Organisational culture, scientific field, minority cultures etc.



Public sector: collaboration (and hindrances)

- When there is not enough (political) common ground to **ensure the goal is shared**, collaboration becomes difficult
- Collaboration across policy fields to **ensure purposeful overlapping** of projects and their evaluation criteria
- Successful collaboration **requires**
 - **Understanding**
 - **Respect**
 - **Time**
 - **Other resources**



Way ahead?

- **Local evaluation needs** mapped and met
- **Local vision of results** hoped for
- **Local concrete actions**



What you see is what you get!

- **Kindness**
gives you eyes to see with whom and how to work
- **Collaboration**

Prison Act § 93

§ 93 Evaluation, Criminological Research

- (1) Treatment programs for prisoners are to be designed, standardized, and ***reviewed for their effectiveness based on scientific knowledge.***
- (2) The correctional system, particularly its task fulfillment and organization, the implementation of its guidelines, as well as the treatment programs and their effects on achieving the correctional goals, shall be ***regularly accompanied and researched scientifically by the criminological service, a university, or another appropriate institution.***

Recommendations and Ways Forward

1. Strengthen national and local forums
2. Establish centralized repositories
3. Invest in training programs
4. Integrate Theory of Change into evaluation systems
5. Continuous refinement of Theory of Change

Case Finland

- The Government adopted an **updated National Action plan** for Prevention and Combating of violent radicalisation and extremism in June 11, 2024
 - This is the fourth program in sequence, and it updates and continues the program that was approved in 2019
 - “The progress of the measures in the Action Plan is assessed annually through process evaluations, **using principles based on evidence-based evaluation**. A questionnaire is used in the evaluation to ensure consistency both among stakeholders and over time.”
- **Some experience with evaluation:**
 - The National P/CVE Action Plan 2016 was evaluated by external evaluators
 - We found the evaluation process to be very valuable
 - However, there were some gaps in our knowledge and available tools.



How to do it - some preliminary ideas

- Objective is not only to evaluate the progress but also to **learn what works and what does not work**
- **Key actors**
 - National P/CVE Network and its thematic sub-groups
 - Researchers
- The evaluation will commence once the implementation begins



How to proceed

- **Discussion in the National P/CVE Network:**
 - Engaging a discussion on evaluation and why we need it, including a presentation by experts in the field
- **Selecting measures** to be evaluated:
 - Identifying and choosing the specific measures that will be subject to evaluation
- **Designing the evaluation process:**
 - Outline the evaluation process, including:
 - **Roles and responsibilities:** defining the roles and responsibilities of all involved parties
 - **Key indicators:** establish the key indicators to be measured
 - **Checkpoints:** Define the key checkpoints and milestones of the evaluation
 - **Communication guidelines:** Develop guidelines for effective communication through the evaluation process











Recommendations for the future:


- 1. Embrace value-conscious technology development, recognizing the non-neutrality of AI and evaluation systems.**

- 4. Ensure ethical alignment between AI systems and human values in evaluation contexts.**






